 - Approximately 1230, Lunch (provided).
 - After racing, post race activities (Beer, trophies, dinner, announcement of teams for Sunday racing), Paisley's parents house.
 - Sunday June 23rd Team Racing
 - 0900 hours: Competitors briefing ashore, Marshall Park Launch Site
 - 0945 hours: Warning, first flight. Other flights to follow as soon as practicable. It is the
